### **Important Questions on the Ballot for the Primary**

Four ballot questions, including three proposed constitutional amendments, will appear on the ballot during the primary election on May 18. Two of them are designed to limit the powers of our governor.

 Proposed Amendment - Article III, Section 9 Termination or Extension of Disaster Emergency Declarations

"Shall the Pennsylvania Constitution be amended to change existing law and increase the power of the General Assembly to unilaterally terminate or extend a disaster emergency declaration—and the powers of Commonwealth agencies to address the disaster regardless of its severity pursuant to that declaration—through passing a concurrent resolution by simple majority, thereby removing the existing check and balance of presenting a resolution to the Governor for approval or disapproval?"

#### What's the Annual Mail-In Ballot Request?

You now have the option to request to be added to the annual mail-in

ballot request list where you'll receive an application to

renew your mail-in ballot request each year. Once your request is approved, you will automatically receive ballots for the remainder of the year, and you do not need to submit an application for each election.  Proposed Constitutional Amendment - Article IV, Disaster Emergency Declaration and Management

"Shall the Pennsylvania Constitution be amended to change existing law so that: a disaster emergency declaration will expire automatically after 21 days, regardless of the severity of the emergency, unless the General Assembly takes action to extend the disaster emergency; the Governor may not declare a new disaster emergency to respond to the dangers facing the Commonwealth unless the General Assembly passes a concurrent resolution; the General Assembly enacts new laws for disaster management?"

Disaster declarations are key to protecting Pennsylvanians and delivering federal and state aid to those in need. These two ballot questions, if passed, would jeopardize the checks and balances that keep one branch of government from becoming too powerful. Vote "NO" to keep partisan gridlock out of state emergencies.


#### A Closer Look at the Proposed Racial Equality Amendment

Voters will be asked to decide if they want to add an amendment to Pennsylvania's Constitution that would prohibit denying an individual their rights based on their race or ethnicity.

 Proposed Constitutional Amendment - Article I, Prohibition Against Denial or Abridgment of Equality of Rights Because of Race or Ethnicity

"Shall the Pennsylvania Constitution be amended by adding a new section providing that equality of rights under the law shall not be denied or abridged because of an individual's race or ethnicity?"

This may seem like an unlikely issue to be brought forward by a Republican-controlled legislature, but public radio

Republican legislators, annoyed at Gov. Wolf's comparatively successful statewide pandemic shutdown last year, want to curtail the governor's future powers to declare a statewide emergency, as shown in two other questions on the ballot.

Votes for the bill fell along party lines, but when a senator from the Philadelphia area added the racial equality bill to the package, it passed almost unanimously. The racial equality amendment came about as a response to police brutality and Black Lives Matter protests, according to WITF.

Under Pennsylvania law, getting a Constitutional amendment in front of the voters requires that the proposed amendment pass both houses of the legislature in two consecutive sessions. And in order to garner enough votes, the emergency powers-limiting bill was tied to the racial equality bill, as the WITF story explained.

So, two for the price of one, however, the measures are independent ballot questions, and voters will vote on them separately.

This amendment applies to all Pennsylvania state, county and local governmental entities, and guarantees equality of rights under the law, according to an explanation provided by the state attorney general. The amendment, if enacted, will become a part of the Pennsylvania Constitution.
